


AQ113 AQQA Aquarium Gravel Cleaner User Manual

1. PRODUCT FEATURES




Powerful Vacuum Cleaner: It has enough suction power to clean every corner of the tank without getting your hands wet - Quick Drainage.

Adjustable length: The aquarium gravel cleaner with 2 extension tubes, can be retrofitted with extension rods and sand washing heads as required. The adjustable range of size S is from 66-79cm/26-31.1 inches, and the size M is from 76-90cm/30-35.4 inches. NOTE: The size adjustment ranges from right-angle to anti-suction strainer basket.






Water change mode: Can be fixed on the aquarium glass, suitable for 6-30mm/0.23-1.18inches thick glass.




Removable and portable: The connector is removable and can be disassembled and cleaned if it is accidentally blocked during water exchange.


Non-return: With polyether-based TPU non-return fitting, for preventing water backflow effectively.



2. PRODUCT DIAGRAM




3. INSTALLATION




4. INSTRUCTIONS FOR USE

1. Connect the water inlet and outlet before using. Put the extension tube into aquarium and the water outlet into a bucket. When using this gravel cleaner, the water outlet must be at least 50cm/19.7inches below the water inlet.



2.Immerse the water inlet into the water. Pump several times with the hand pump to draw in water.
