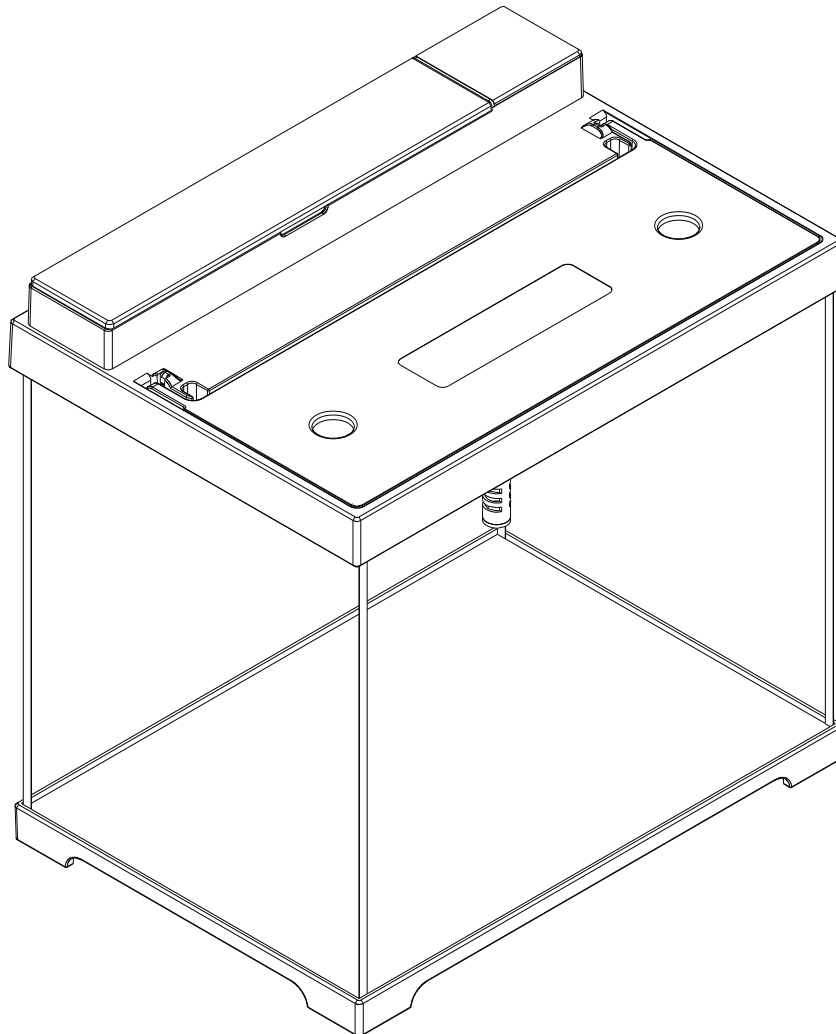

1.PRODUCT FEATURES

One-piece design: The integrated fish tank design is collocated with an intelligent integrated tank cover. The lamp, water pump and filter are integrated into the upper cover, making the fish tank ready to use as soon as you open it.

Ultra-clear Glass: High-quality ultra-clear glass with a high transmittance of 91.5% truly restores the fish tank's natural ecology.

Ecological Circulation System: A double-layer filtration system collocated with a biochemical filter cotton and nitrifying bacteria filter material. Culture nitrifying bacteria when filtering, providing a favourable water quality environment for the aquarium.

4-color LED light with high brightness: 4 Light modes, restore daylight brightness under different light modes when brightening, full light mode - blue mode - yellow mode - red mode.

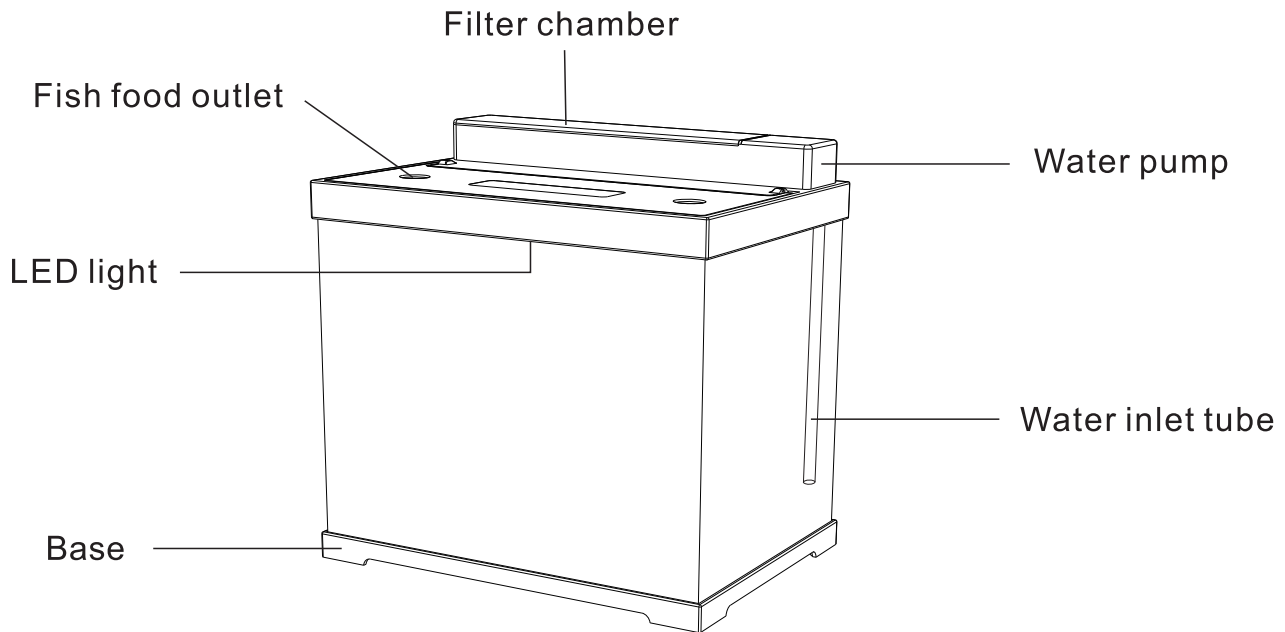
Ultra-quiet: Embedded pump design, ultra-quiet operation, to create a comfortable and quiet environment for fish.

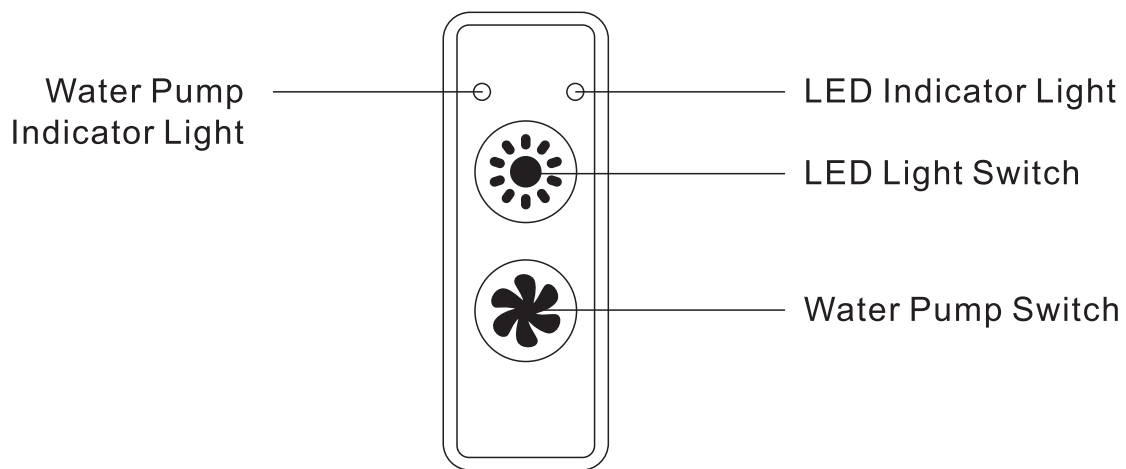
3. INSTRUCTIONS




1).Instructions of Controller:

Long press to turn on


Each press changes one color, long press turns off the light source

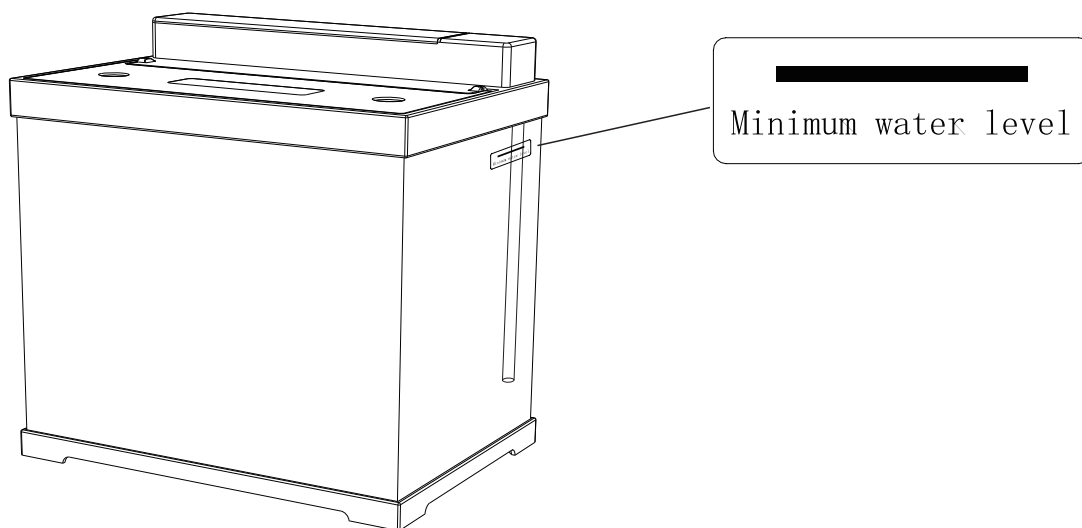


A: LED light

Long press  3 seconds light on, light and indicator on simultaneously; every time you press the light, the colour cycle changes: full universal light - blue light - yellow light - red light. Long press 3 seconds light off.

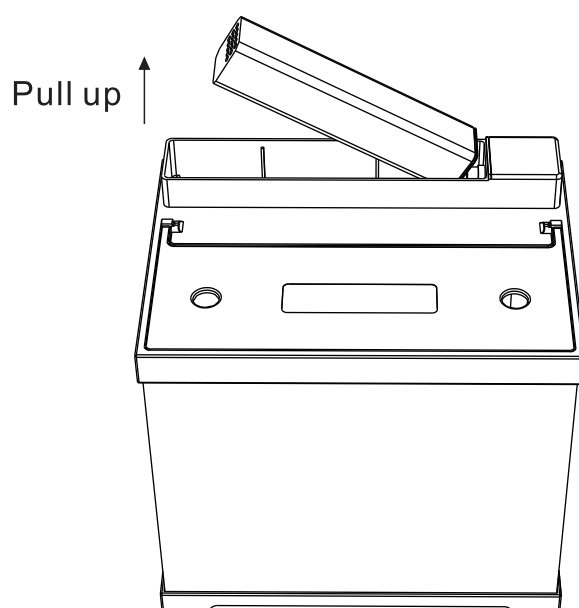
B: Water pump

When first using, add the water to the lowest water level (the lowest is indicated on the right side of the tank). Press the pump button  and the indicator lights up simultaneously, indicating that the pump works normally.

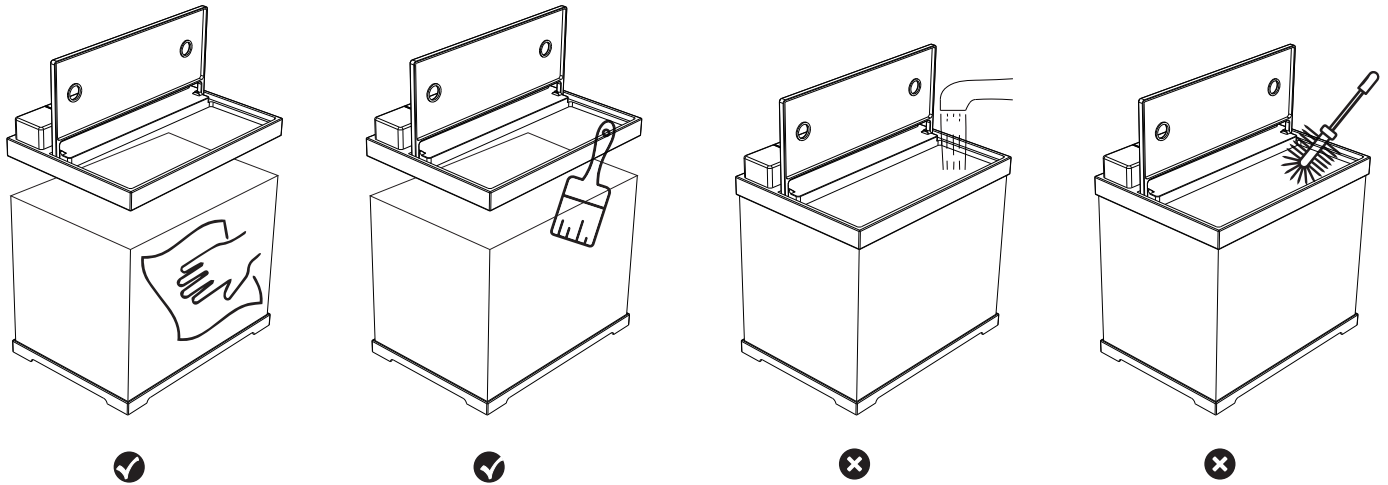


2).Clean the fish tank

A: It is recommended to clean the fish tank filter chamber regularly for 1-2 weeks.



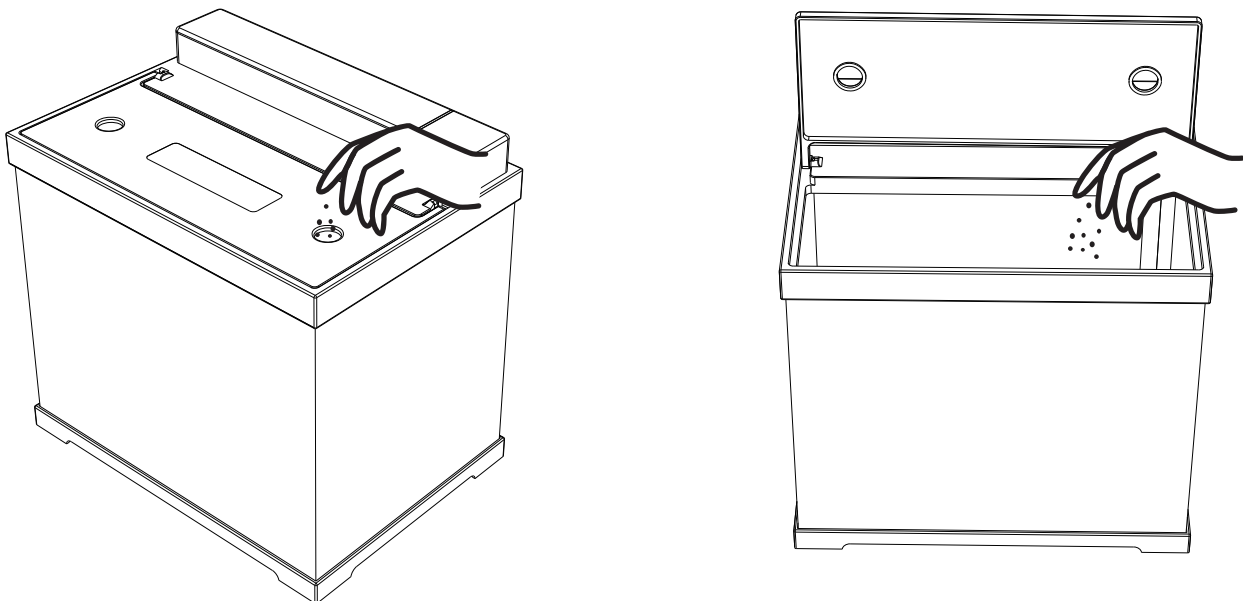
B: The fish tank can be cleaned with towels and soft brushes. Please do not use sharp brushes or strong current to wash.



3).Feed

You can open the upper cover for feeding, or feed food through small round holes in the panel.

- Upper cover with hole design
- Balancing feeding and venting
- Fish feed can be put into the tank through the small holes on the panel



ⓘ When the fish tank is in use, the water pump is recommended to be turned on simultaneously. In the process of filtering water quality, it promotes water circulation and increases oxygen content in water.
